### MINUTES FOR THE CLINTON COUNTY COUNCIL MEETING JULY 9, 2019

The Clinton County Council met in the Commissioner's Meeting Room at the Clinton County Courthouse, Frankfort, Indiana on July 9, 2018 at the hour of 9:00 a.m. regular Council meeting, pursuant in accordance with law and publication as evidence by proof of the minutes of the last meeting, and any other business that may come before it. Council President Alan Dunn called the meeting to order and led the Pledge of Allegiance. On call to order the following members were shown to be present or absent.

Britt Ostler, Clinton County Auditor, was present to record the proceedings of the Council.

Others present were, First Deputy Auditor Janet Lloyd, Sheriff Rick Kelly, Ashley Kelly, Kevin Myers, Rodney Wann, Beth Keeney, Greg Miller, and others as mentioned in the minutes.

Council member Beard moved seconded by Council member Hensley to approve the minutes of the June 11, 2019 meeting. Motion carried 6-0. Council member Chynoweth abstaining.

Council member Beard moved seconded by Council member Gascho to approve the minutes of the June 7, 2019 meeting. Motion carried 6-0. Council member Chynoweth abstaining.

Council member Beard moved seconded by Council member Gascho to approve the minutes of the Joint Special Session and Public Hearing on Monday, May 20, 2019. Motion carried 7-0.

#### **COMMUNITY CORRECTIONS**

Community Corrections Director Brett Barton stated there were 68 clients on electronic monitoring in June 2019 with 4 of those being juveniles and 4 on CTP. They are trying new monitoring equipment for their clients. This would equip all clients with GPS and a cost savings of \$1800 per month based on a 75 person caseload. They should know within 30 days if they change to this new system. Field Officers start pre-basic training for firearms and radios at the jail. They should be equipped by the end of the year.

#### **PROBATION**

Nancy sent reports for juvenile detention costs in the amount of \$1820 for the month of June 2019.

#### **SHERIFF**

Sheriff Kelly presented the camera system bids from Security Pro and Apex. The current system is failing due to its age and can no longer be upgraded. It's become an emergency to replace the camera and monitoring system.

Council member Hussey will recuse himself from voting and instead answer any questions as a vendor since he is with Apex.

Commissioner Woods suggested the monies be taken from Rainy Day for the security system. Council member Dunn suggested the monies can also be taken from the Landfill Tipping Fund. Security Pro- \$121,757 (phase one) \$114,000 (phase two)= \$235,757 Apex- \$208,885.45

Motion by Council member Beard seconded by Council member Myers to support funding the contract from Apex for a new camera system for \$208,885.45 which will come from the Rainy Day Fund. Motion 6-0. With Council member Hussey abstaining.

Sheriff Sale Administrative Fund (4009) has a substantial amount in the fund. The Sheriff's Office is considering using some of these monies to purchase a digital sign for \$29,017.29 to advertise the sheriff sale properties. The sign could also be used to advertise school closings,

road closures, Commissioner and Council meetings, etc. The proposed idea is to place this in front of the Sheriff's Office, since it is one of the busiest roadways in the County and would be highly visible. This fund may also be used to pay for the sheriff pension each year. An Additional Appropriation would need to be completed to use these monies for the pension.

Motion from Council member Chynoweth seconded by Council member Hensley to support the purchase of a digital sign in the amount up to \$30,000. Motion 7-0.

Maton Ashley Kelly spoke regarding savings to the County. The first being the medical contract which saved \$38,295.28 from January to May. Per statute the County is responsible to pay medicare reimbursement, plus 4%. In 2018, the County paid \$51,493.32 for inmate medical bills. In 2019, we have paid \$1574.16. \$15,000 of the medical contract can come out of the DOC grant. The new collection of \$15.00 medical co-pays which started in April has collected \$2,907.53 so far.

The new food vendor, Kellwell Foods, has been at a \$600.00 per week savings on food.
